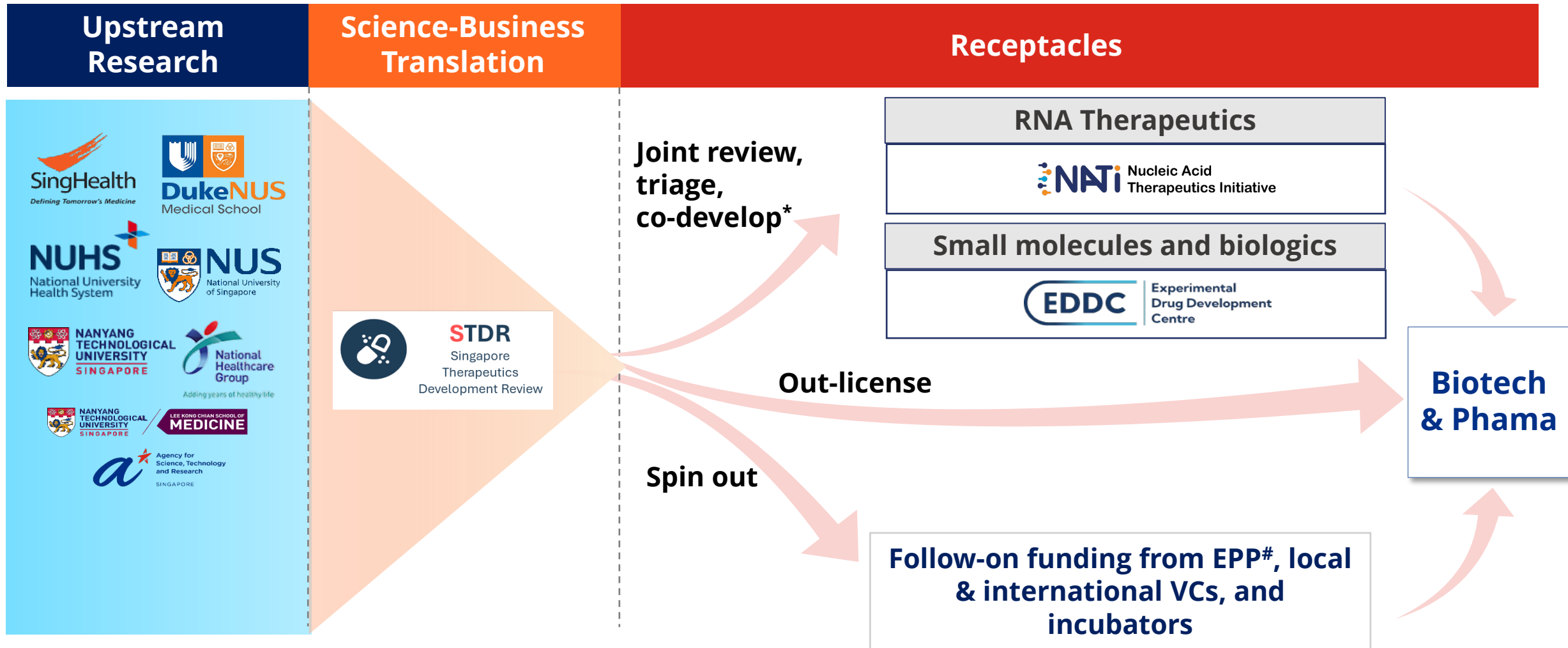

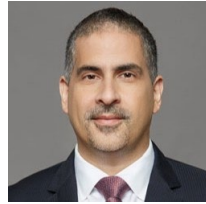

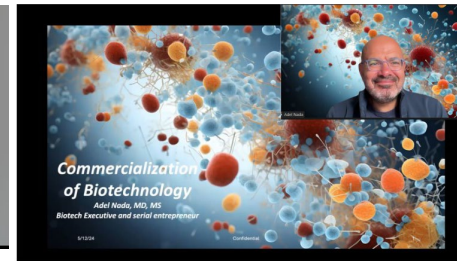

Summary

- STDR aims to strengthen local **drug development and biotech pipelines**. We strategically **leverage industry expertise** across all of our initiatives.
- In RIE2030, STDR will place greater emphasis on translating scientific discoveries into viable business opportunities. We will focus on improving project quality and sharpening the translational focus, by strengthening **Project Management** and enhancing support for venture creation through the new **Venture Leads Scheme**.
- STDR will continue to work in close synergy with ecosystem partners and serve as a **national-level funnel** for promising early-stage academic projects to enter downstream translational receptacles (e.g. EDDC, NATi, and pharma/biotech companies).
